Approximately 1 week before the publication of the 2017 Hypertension Clinical Practice Guidelines,¹ Prof Marc Twagirumukiza, African Society of Hypertension Executive General Secretary, Prof Oh Min Sen Vernon, Asian Society of Hypertension President, Dr Joey P. Considering scientific advances from the past 2 years and informed by the latest published guidelines, it is now time to continue the conversation we began in 2016.
